1. RULES

The Race will be governed by 2005-2008 Racing Rules of Sailing (RRS) and The Leukemia Cup Regatta Sailing Instructions. Pontchartrain Yacht Club (PontYC) will administer the Race.

2. CLASSES

PHRF: Spinnaker, Non-Spinnaker, and Multi-Hull. Class breaks will be defined at the Skippers Meeting.

One-Design Keel Boats: J/30

One-Design Board Boats: O'pen BIC & Optimist Green Fleet.

Four boats needed to make a class.

3. RACE FORMAT

All racing will be conducted on custom courses with fixed or temporary marks on the North Shore of Lake Pontchartrain approximately one (1) nautical mile south of PontYC.

4. ADVERTISING

The regatta is designated Category A in accordance ISAF Regulation 20 for all classes. Racers may upgrade to Category C which allows advertising if their boat raises \$250 or more with no additional entry fee.

5. ELIGIBILITY

Competitors: The race is open to all. Competitors need not be a member of a yacht club.

Boat: Participating PHRF boats must have a current GYA PHRF certificate. Boats without a current GYA PHRF certificate will be assigned a rating based upon similar boats. The assigned rating cannot be protested.

6. ENTRY FEES

Please register early for this worthy cause so that the event can be properly planned.

- Awards ceremony at Pontchartrain Yacht Club following the conclusion of races.

A total of two (2) races for PHRF classes, five (5) races for J-30's, and seven (7) races for Board Boats and Optimist classes will be attempted for the event.

8. REGISTRATION
